

Manifesto

- 1- Legalisation of child erotica on any form, but only as long as the children and their parents agree to take part on it and are properly compensated.
- 2- Hardcore child pornography will remain ILLEGAL unless it is fantasy faked with technology, like for example cartoons, computer animation or real digital photos manipulated.
- 3- Amnesty for all prisoners convicted of child erotica viewing, this amnesty will also apply to viewers of real hardcore child pornography convicted before child erotica legalisation. A fixed compensation will be paid to them.
- 4- Disbanding of all anti child erotica organisations, no children's charity will be approved by the government unless they clearly recognise that child erotica viewing is an activity beneficial for society and the children taking part on it.
- 5- Incitement to hate child erotica viewers will be made a criminal offence punishable with prison, everyone will have the right to live in freedom and peace without being harassed regardless of their thoughts.
- 6- A campaign via press, television, internet and billboards will be started nationwide to put right so many years of lies and deceiving, the public will be told what child erotica is and interviews with child models and their parents will be promoted, the campaigns will include graphical examples of child erotica artists.(once it is legalised).
- 7- A Child Erotica Week of the year will be created for public awareness, the week will involve exhibitions and live shows with nude children posing erotically, and will be open to adults and minors
- 8- A body will be created to make sure that child models are properly looked after, and the proceeds of their career will not be given to their parents but put in a savings bank account available to the child model on his/her eighteen birthday. Imports of child erotica from countries that can not guarantee the models have not been properly treated and paid, will be banned.
- 9- The government will set up an organisation to inform the parents what they need to do to let their children take part in child erotica modelling, this body will promote child erotica exports Worldwide, the taxes collected in exports will be put back into the community building playgrounds, schools and hospitals for children. (once it is legalised)
- 10- SEXUAL CONTACT BETWEEN AN ADULT AND A CHILD WILL REMAIN A CRIMINAL OFFENCE.
